### **Stage 3 Excursion – Term 2 Canberra Capital Tour Camp**

As part of our 2020 History program, Stage 3 students have the opportunity to attend a 3 day Canberra Capital tour from Wednesday 17<sup>th</sup> – Friday 19<sup>th</sup> June 2020.

This excursion has been planned to supplement the Semester 1 History unit – Government and Democracy. Participating in a variety of educational programs will assist students to gain a better understanding of our history, culture, heritage and democracy.

Travel to and from the various venues will be by seat-belted coach. Students will visit venues such as The Royal Australian Mint, Parliament House, Telstra Tower and Questacon. The accompanying staff will be Ms McMillan, Mrs Cairnduff, Mr Beazley and Mrs Wilkins who are all CPR trained and will supervise the students in all activities.

The total cost of the excursion is **\$380.00**. Places are limited.
